Step 1: Establish strong company management systems

- 1.B Structure internal management systems to support supply chain due diligence.
- Additional responsibility has been assigned to Compliance officer to look over the compliance of Ethical sourcing policy.
- All key employees involved in sourcing and procurement have been trained.
- List of Suppliers has been maintained along with status of their social and ethical compliance.
- Ongoing monitoring of each supplies and associated suppliers is carried out with the help of tools such as digital media, web search, review of supply documents, declaration and market intelligence etc.
- 1.C Establish a system of controls and transparency over the minerals supply chain.
- Supplier upstream information collection process started to obtain CAHRA's information and Ethical sourcing compliance at supplier level.
- **1.D** Strengthen company engagement with suppliers.
- Supplier questionnaire has been circulated and we are following up with them.
- We are also obtaining the vital information about suppliers from social platforms and social compliance registration such as RJC.
- We are compiling filled supplier questionnaire data, after analysis we will be formulate supplier engagement practices based on risk reported at each supplier level (if any)
- 1.E Establish a company-level, or industry wide, grievance mechanism as an early warning risk-awareness system.
- We have established the grievance handling policy and procedure, contact details has been provided in our Social and Ethical policy on our website.
